



INTERNET ACCESS REGULATIONS

THE WIRELESS INTERNET ACCESS SERVICE

The wireless Internet access service is realized through a network of access points in the IEEE802b/g technology with bandwidth up to 6Mb/s for the connected device. The service is payable. Each User will receive a voucher containing individual access codes and instructions for logging onto the network. The codes allow for access to the network and, depending on options purchased, are valid for the whole event, from the time of the first login to the network. Separate access must be purchased for each device. The network card of the device is associated with the purchased voucher at the time of the first login. It is possible to increase bandwidth of the connection with additional payment.

THE WIRED INTERNET ACCESS SERVICE

Within the service a wired connection with a speed of up to 6Mb/s will be delivered for each connected device. A designated location on the User's stand will be connected by unshielded twisted pair cable (UTP cat5e) terminated with RJ45 connectors. The connection is payable and is not assigned to a specific device. It is possible to increase the bandwidth of the connection. A User can, within his stand and independently, separate the signal for up to 5 additional devices. In the event of using wireless access technology for distributing the signal, access to the connection should be secured in order to prevent unauthorized persons from using it. The instanded equipment should be configured in such a way as to not interfere with the operation of the equipment deployed by the Service Provider. The Service Provider reserves the right to force the User to change the device configuration, including, if necessary, by shutting down the Internet access.

ROUTABLE, PUBLIC IP ADDRESS

GENERAL PROVISIONS

1. Before using the Service, every User should become familiar with the provisions of these Regulations. Logging to the internet and starting to use the Service is understood as acceptance of the Regulations. Complaints resulting from failure to comply with the provisions of these Regulations shall not be considered.

2. The User shall not use the provided network to, for example:

- send and publish the contents which are illegal or which are the intellectual property of a person other than the User;

- send and publish the contents which may infringe moral rights of any person;
- distribute, on a mass scale, advertising messages not requested by recipients (spamming);
- forward IP packets with fake address of the sender;
- attempt illegal access to IT systems of other users of the network;
- distribute computer viruses and other software which may damage the computes of other users of the network;
- overload the band by making available certain network services, e.g. Web servers, IRC, NNTP etc.;
- disrupt or impede the operation of the network in a way other than those listed above.

3. The Service Provider reserves the right to record the internet traffic and to process personal data of Users only for the purpose of Service provision.

4. The Service Provider shall not be held liable for any interruptions, delays in provision of Services resulting from the unpredictable causes and phenomena beyond control of the Service Provider, such as interruptions and disruptions of the services provided by telecommunication providers, telecommunication link and electric energy providers, damage to infrastructure caused by atmospheric phenomena and third party actions.

5. The Service Provider shall not be held liable for:

- unauthorised use of the software or other works protected by intellectual property rights and available on the internet;
- damages caused by the software provided by third parties;
- User's activity in the internet, including the damages caused by such activity;
- data collected or provided by the User;
- damage which the User may incur in relation to using the Service, in particular for:
 - a) loss of data or damage to the User's software;
 - b) disclosure of the User's data;
 - c) delay in receiving or transmitting data caused by lack of transmission, incorrect transmission, delays or interruptions in access to the internet.
